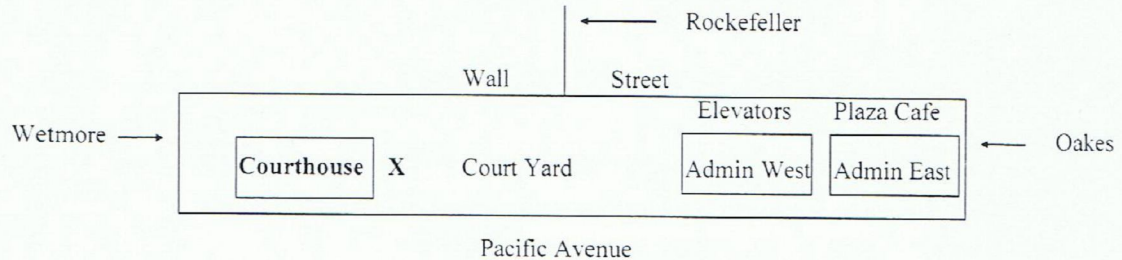
TIME: **Doors Open** at 6:15 PM and are locked at 6:30 PM. Panels begin as soon as registration is completed and last approximately two hours.

NOTE: Do not use alcohol or any other drug 24 hours prior to attending the class. If we suspect that you are under the influence, you will be refused admittance.

Location: Panels are held at: Snohomish County Courthouse Lobby (by metal detector)
3000 Rockefeller Avenue, Everett, WA 98201



Enter the lobby from the courtyard when admitted by the security guard. You will go through a metal detector so please plan accordingly.

Registration: Registration through your court is preferred unless time is an issue. You can register for an upcoming panel by calling the Victim Panel Voicemail at 425-388-7269.

Fee: **\$45 cash**, money order, or cashier's check will be accepted at the door starting at 6:15 p.m. on the day of your scheduled Victim Panel. You have until 6:00pm on the date that you are registered to attend to notify us of a cancellation, or to reschedule. If you do not notify us, you will be charged an additional \$10.00 fee. No one will be admitted without proper payment. No personal checks or credit/debit cards will be accepted.

Time: Doors Open at 6:15 p.m. Arrive in plenty of time, as **NO ONE IS ADMITTED AFTER 6:30 P.M.** Panels begin as soon as registration is completed.

Guests: Friends and relatives and Driver's Ed students are welcome, but may NOT sit with attendees. Children under 12 are not permitted. (No fee is required for guests and Driver's Ed students.)

Paperwork: All Court/Victim Panel paperwork is mailed to your referring court following your attendance.

Behavior: You are required to attend straight and sober. If the staff or County Marshal suspect that you are under the influence of drugs including alcohol; you will not be allowed to attend and your court will be notified. You are expected to pay attention throughout the presentation. Distracting behavior is not allowed (no eating, drinking, talking to others, etc.) If you are disruptive or disrespectful to the speakers, staff or any other attendee, you will be asked to leave and your court will be notified.

Credit: You will receive credit for attending as long as you: (1) attend the complete presentation; (2) follow the rules listed above; and (3) fill out all paperwork as requested.
